

BIIVIP PRIVACY AND PERSONAL DATA PROTECTION POLICY

1. This statement includes the privacy policy of Biivip.com (Mehmet Emin Özdeş) and the policy on the Protection of Personal Data. Biivip.com, in order to protect the privacy of the users visiting the site, individually and institutionally, and to ensure that they benefit from all the services offered on the site in the best way; has adopted various principles for information and data security. These privacy policies are; Biivip.com and all affiliated sites, mobile applications and all sub-services are determined and declared to be applied in terms of data collection and/or use. By using Biivip.com and its mobile applications, all of these principles are deemed to have been accepted by the Users.

2. Biivip.com requests some personal information from you during the membership phase and afterwards. The information you have provided will not be used in any scope other than the rules and purposes specified in the Membership and User Agreement and the Clarification Text, and will not be shared with third parties.

3. The information that users enter into the system is protected in confidentiality and trust, using the most up-to-date and advanced security technologies. In addition, the highest level of protection is provided against possible attacks and data theft attempts by constantly monitoring sectoral developments and developing dangers in the field of data security and by conducting regular tests.

4. Access to users' accounts in the system is kept from third parties using SSL (Secure Socket Layer) technology. SSL technology performs two basic tasks between the server and the user's internet browser, such as authentication and connection encryption.

5. Biivip.com declares and undertakes not to engage in commercial communication activities against the user's request, not to do marketing without permission, and to provide tools that will enable the user to exit the system free of charge and easily.

6. Biivip.com detects and uses the IP address of users when necessary, in order to detect system-related problems and to resolve such problems as quickly as possible. IP addresses can also be used to identify users in a general way and to gather comprehensive demographic information.

7. Biivip.com's traffic data storage obligations specified in Law No. 5651 and related regulations, and transaction data storage obligations specified in Tax Procedure Law No. 213 and related regulations are also reserved.

8. Biivip.com may provide links to other sites from within the service and mobile applications it provides. It can publish the advertisements, application forms, announcements, surveys of the third parties with which it has a contract. Biivip.com may direct Users to sites / services / mobile applications of advertisers or contracted 3rd parties through these forms, announcements, surveys and advertisements. Biivip.com does not bear any responsibility for the privacy practices and policies of other sites and/or mobile applications accessed through this link, as well as any visual and textual content they contain.

9. Users are responsible for the privacy and security of their accounts on the sites of third parties and institutions that are linked through the site. Biivip.com cannot be held responsible for the privacy policy and Personal Data Protection policy of these third parties.

10. Users are responsible for the security and confidentiality of their accounts and passwords on the site. Biivip.com is not responsible for any damages that may arise from not backing up any data during the use of the site or during the service procurement, or any damage to any personal data.

11. The personal / corporate information of the user is understood as name and surname, address, telephone number, e-mail address and any other information to identify the user. Unless otherwise stated in this privacy statement, Biivip.com will not disclose any of the individual / corporate information to third parties, except for the cases listed below. These situations are;

- 11.1. In cases where it is necessary to comply with the legal obligations in the current legislation and effective international agreements in domestic law,
- 11.2. In cases related to the fulfillment of the requirements of the contracts between Biivip.com and its users and their implementation,
- 11.3. In cases where information about users is requested in line with an investigation or investigation carried out by the authorized administrative and/or judicial authorities in accordance with the procedural method,
- 11.4. In cases where it is necessary to provide information in order to protect the rights or security of users.

12. Biivip.com accepts that it is an obligation to keep the confidential information given to it private and confidential and to keep it as a secret, and that it is necessary to ensure and maintain confidentiality, to prevent all or any part of the confidential information from entering the public domain or unauthorized use or disclosure to a third party. hereby undertakes to take all necessary technical, legal and managerial measures and to show all due diligence.

13. In case of making use of a paid service on the site or in cases where a purchase is made through the advertisements published on the site, the credit card information collected through the payment institution or payment intermediary during the purchases made by the Users on the Site can be used for invoicing the purchased products and services.

14. Biivip.com never requests a credit card number, user name, password or password in the e-mails it will send. Data contained in e-mails can be viewed by third parties. Biivip.com cannot guarantee the security of information transmitted from User emails under any circumstances.

15. Biivip.com can obtain the usage information of users on Biivip.com and mobile applications by using cookies (Cookie), which is a technical communication file, and

information about Application usage with IP or Social Network account user data. The technical communication file called a cookie helps to obtain statistical information about how many people use the website in a temporal proportion, for what purpose, how many times a person visits the relevant website and how long they stay, and to produce advertisements and content with dynamic variety from user pages specially designed for users. It is a data file that is designed and used to help. If users wish, they can always change the settings of their browsers so that cookies are not placed on their computers or a warning is given when a file of these 4 types is sent.

16. Information that may be requested from users who respond to periodic or non-periodic surveys that may be organized by Biivip.com within the site or Applications, or who ask questions to the help desk, may also be requested by Biivip.com and its collaborating persons or institutions for direct marketing to these users. It can also be used to make statistical analyzes and create a special database. Surveys or helpdesk may be services offered by 3rd parties as per the agreement.

17. Pursuant to the Law No. 6698 on the Processing of Personal Data, the personal data obtained may be processed by Biivip.com for up-to-date, legitimate purposes, in accordance with the law and honesty, in a timely manner and in accordance with the relevant legislation. 18. The personal data obtained may be transferred, stored and processed within the scope of the relevant legislation and the foreseen security measures in another country where the service service providers that Biivip.com works in the country or abroad. Detailed information is available in the Personal Data Protection Clarification Text on Biivip.com.

19. Personal data, (i) It is clearly stipulated in the laws, (ii) It is necessary to process the personal data of the parties to the contract, provided that it is directly related to the establishment or performance of a contract, (iii) It is mandatory for the data controller to fulfill its legal obligation, (iv) Personal data may be processed without the consent of the owner, for one or more of the reasons that the data subject has been made public by himself.

20. The User, as regulated in the Personal Data Protection Clarification Text; Pursuant to article 11 of the KVKK, by applying to Biivip.com;

- 20.1. To learn whether personal data is processed, to request information about it if it is,
- 20.2. Learning the purpose of processing personal data and whether it is used in accordance with the purpose,
- 20.3. Knowing the third parties to whom personal data is transferred at home or abroad,
- 20.4. Requesting correction of personal data if it is incomplete or incorrectly processed,
- 20.5. Requesting the deletion or destruction of personal data in accordance with the relevant legislation,

- 20.6. Requesting notification of correction, deletion and destruction processes in accordance with the relevant legislation to third parties to whom this data has been transferred,
- 20.7. Objecting to the emergence of a result against the person himself by analyzing the processed data exclusively through automated systems,
- 20.8. In case of loss due to unlawful processing of personal data, they have the right to demand the compensation of the damage.
